## MARTHA NUSSBAUM'S PHILOSOPHICAL FOUNDATIONS

## PHILOSOPHICAL IMPACT ON SOCIAL THOUGHT

## THE CAPABILITY APPROACH AND ITS RELEVANCE TO NOT-FOR-PROFIT ORGANIZATIONS

THE CAPABILITY APPROACH, DEVELOPED BY MARTHA NUSSBAUM IN COLLABORATION WITH ECONOMIST AMARTYA SEN, IS A TRANSFORMATIVE FRAMEWORK FOR ASSESSING HUMAN WELL-BEING AND DEVELOPMENT. IT MOVES BEYOND INCOME AND RESOURCE-BASED EVALUATIONS TO FOCUS ON WHAT INDIVIDUALS ARE ACTUALLY ABLE TO DO AND BE – THEIR REAL FREEDOMS AND OPPORTUNITIES. THIS APPROACH HAS BECOME HIGHLY INFLUENTIAL IN SHAPING POLICIES AND PRACTICES WITHIN NOT-FOR-PROFIT ORGANIZATIONS COMMITTED TO SOCIAL JUSTICE AND HUMAN DEVELOPMENT.

### CORE ELEMENTS OF THE CAPABILITY APPROACH

NUSSBAUM'S VERSION OF THE CAPABILITY APPROACH IDENTIFIES A LIST OF CENTRAL CAPABILITIES ESSENTIAL FOR A DIGNIFIED LIFE, INCLUDING LIFE, BODILY HEALTH, EMOTIONAL WELL-BEING, PRACTICAL REASON, AND AFFILIATION. THESE CAPABILITIES SERVE AS BENCHMARKS FOR EVALUATING SOCIAL ARRANGEMENTS AND GUIDING INTERVENTIONS AIMED AT EXPANDING INDIVIDUAL FREEDOMS. NOT-FOR-PROFIT ORGANIZATIONS CAN UTILIZE THIS FRAMEWORK TO BETTER UNDERSTAND AND MEASURE THE IMPACT OF THEIR PROGRAMS ON BENEFICIARIES' LIVES.

### IMPLEMENTATION IN NONPROFIT STRATEGY AND PROGRAM DESIGN

INCORPORATING THE CAPABILITY APPROACH ALLOWS NOT-FOR-PROFIT ORGANIZATIONS TO:

- DESIGN PROGRAMS THAT ADDRESS MULTIPLE DIMENSIONS OF HUMAN WELL-BEING RATHER THAN FOCUSING SOLELY ON ECONOMIC OUTCOMES.
- ASSESS THE EFFECTIVENESS OF INTERVENTIONS BASED ON THE ENHANCEMENT OF INDIVIDUAL CAPABILITIES AND FREEDOMS.
- PROMOTE INCLUSIVITY BY RECOGNIZING AND ACCOMMODATING DIVERSE NEEDS AND SOCIAL CONTEXTS.
- ADVOCATE FOR POLICIES THAT ENSURE EQUITABLE ACCESS TO ESSENTIAL RESOURCES AND OPPORTUNITIES.

THIS MULTIDIMENSIONAL LENS HELPS NONPROFITS ALIGN THEIR MISSION WITH A COMPREHENSIVE UNDERSTANDING OF JUSTICE AND HUMAN FLOURISHING, ECHOING THE ETHICAL IMPERATIVES IN NUSSBAUM'S WORK.

## ETHICAL CONSIDERATIONS IN NOT-FOR-PROFIT WORK INSPIRED BY NUSSBAUM
