## OVERVIEW OF NURSING SCOPE OF PRACTICE

THE NURSING SCOPE OF PRACTICE DEFINES THE PROCEDURES, ACTIONS, AND PROCESSES THAT A NURSE IS PERMITTED TO UNDERTAKE IN ACCORDANCE WITH THEIR EDUCATION, TRAINING, AND REGULATORY AUTHORITY. IT ESTABLISHES PROFESSIONAL BOUNDARIES TO ENSURE PATIENT SAFETY AND QUALITY CARE. THE SCOPE IS INFLUENCED BY STATE NURSING BOARDS, INSTITUTIONAL POLICIES, AND NATIONAL STANDARDS. IT TYPICALLY INCLUDES ASSESSMENT, DIAGNOSIS, PLANNING, IMPLEMENTATION, AND EVALUATION OF PATIENT CARE. NURSES MUST OPERATE WITHIN THIS FRAMEWORK TO MAINTAIN LICENSURE AND UPHOLD ETHICAL RESPONSIBILITIES.

## DEFINITION AND IMPORTANCE

- DOCUMENTATION AND REPORTING

## REGISTERED NURSE (RN) SCOPE OF PRACTICE EXAMPLES

REGISTERED NURSES PLAY A CRITICAL ROLE IN PATIENT CARE, OFTEN SERVING AS PRIMARY CAREGIVERS IN HOSPITALS, CLINICS, AND COMMUNITY SETTINGS. THEIR SCOPE OF PRACTICE ENCOMPASSES A BROAD RANGE OF CLINICAL AND ADMINISTRATIVE RESPONSIBILITIES.

### CLINICAL RESPONSIBILITIES

RNS CONDUCT COMPREHENSIVE PATIENT ASSESSMENTS, INCLUDING PHYSICAL EXAMINATIONS AND HEALTH HISTORY REVIEWS. THEY INTERPRET DIAGNOSTIC TESTS, MONITOR PATIENT CONDITIONS, AND IMPLEMENT NURSING INTERVENTIONS. ADMINISTERING MEDICATIONS AND INTRAVENOUS THERAPIES, WOUND CARE, AND MANAGING MEDICAL EQUIPMENT ARE STANDARD TASKS. THEY ALSO PROVIDE EMOTIONAL SUPPORT AND EDUCATION TO PATIENTS AND FAMILIES.

### CARE COORDINATION AND COLLABORATION

RNS COORDINATE CARE BY COLLABORATING WITH PHYSICIANS, THERAPISTS, AND SOCIAL WORKERS TO DEVELOP AND ADJUST TREATMENT PLANS. THEY ADVOCATE FOR PATIENT NEEDS AND ENSURE CONTINUITY OF CARE ACROSS DIFFERENT SERVICES AND SETTINGS.

### EXAMPLES OF RN SCOPE OF PRACTICE ACTIVITIES

1. PERFORMING INITIAL PATIENT ASSESSMENTS AND DOCUMENTING FINDINGS.
2. ADMINISTERING PRESCRIBED MEDICATIONS AND MONITORING FOR SIDE EFFECTS.
3. EDUCATING PATIENTS ABOUT DISEASE MANAGEMENT AND PREVENTIVE CARE.

## LICENSED PRACTICAL NURSE (LPN) SCOPE OF PRACTICE EXAMPLES

LICENSED PRACTICAL NURSES PROVIDE ESSENTIAL BEDSIDE CARE UNDER THE SUPERVISION OF RNS AND PHYSICIANS. THEIR SCOPE OF PRACTICE IS MORE LIMITED BUT REMAINS VITAL TO PATIENT SUPPORT AND ROUTINE CLINICAL FUNCTIONS.

### DIRECT PATIENT CARE TASKS

LPNS PERFORM BASIC NURSING DUTIES SUCH AS TAKING VITAL SIGNS, ASSISTING WITH ACTIVITIES OF DAILY LIVING, AND PROVIDING WOUND CARE. THEY ADMINISTER CERTAIN MEDICATIONS AND COLLECT SAMPLES FOR LABORATORY TESTING WITHIN

THEIR TRAINING AND STATE REGULATIONS.

## LIMITATIONS AND SUPERVISION

LPNS TYPICALLY DO NOT PERFORM COMPLEX ASSESSMENTS OR DEVELOP CARE PLANS INDEPENDENTLY. THEY WORK UNDER THE DIRECTION OF RNS OR OTHER LICENSED HEALTHCARE PROVIDERS, ENSURING ADHERENCE TO ESTABLISHED PROTOCOLS.

## EXAMPLES OF LPN SCOPE OF PRACTICE ACTIVITIES

- MEASURING AND RECORDING BLOOD PRESSURE, TEMPERATURE, AND PULSE.
- ASSISTING PATIENTS WITH PERSONAL HYGIENE AND MOBILITY.
- CHANGING DRESSINGS AND MONITORING WOUND HEALING PROGRESS.
- ADMINISTERING ORAL AND INJECTABLE MEDICATIONS AS PERMITTED.
- DOCUMENTING PATIENT CARE AND REPORTING OBSERVATIONS.

## ADVANCED PRACTICE REGISTERED NURSE (APRN) SCOPE OF PRACTICE EXAMPLES

ADVANCED PRACTICE REGISTERED NURSES HAVE ACQUIRED GRADUATE-LEVEL EDUCATION AND CERTIFICATION TO PROVIDE HIGH-LEVEL CLINICAL CARE. THEIR SCOPE OF PRACTICE INCLUDES DIAGNOSIS, TREATMENT, AND MANAGEMENT OF COMPLEX HEALTH CONDITIONS.

## TYPES OF APRNs AND ROLES

APRN ROLES INCLUDE NURSE PRACTITIONERS (NPs), CLINICAL NURSE SPECIALISTS (CNSs), NURSE ANESTHETISTS (CRNAs), AND NURSE MIDWIVES (CNMs). EACH SPECIALTY HAS DISTINCT PRACTICE AREAS AND RESPONSIBILITIES BASED ON EDUCATION AND CERTIFICATION.

## EXPANDED CLINICAL FUNCTIONS

APRN SCOPE INCLUDES ORDERING AND INTERPRETING DIAGNOSTIC TESTS, PRESCRIBING MEDICATIONS, AND INITIATING TREATMENT PLANS INDEPENDENTLY IN MANY STATES. THEY OFTEN SERVE AS PRIMARY CARE PROVIDERS, FOCUSING ON HEALTH PROMOTION, DISEASE PREVENTION, AND CHRONIC DISEASE MANAGEMENT.

## EXAMPLES OF APRN SCOPE OF PRACTICE ACTIVITIES

1. CONDUCTING PHYSICAL EXAMS AND DIAGNOSING ILLNESSES.
2. PRESCRIBING MEDICATIONS, INCLUDING CONTROLLED SUBSTANCES.
3. PERFORMING PROCEDURES SUCH AS SUTURING AND LUMBAR PUNCTURES.

4. PROVIDING PRENATAL AND POSTNATAL CARE (FOR NURSE MIDWIVES).

5. DEVELOPING AND MANAGING COMPREHENSIVE TREATMENT PLANS.

## **FACTORS INFLUENCING NURSING SCOPE OF PRACTICE**

SEVERAL FACTORS AFFECT THE NURSING SCOPE OF PRACTICE, SHAPING WHAT NURSES CAN LEGALLY AND ETHICALLY PERFORM IN THEIR ROLES. UNDERSTANDING THESE FACTORS IS CRUCIAL FOR COMPLIANCE AND PROFESSIONAL DEVELOPMENT.

### **STATE AND FEDERAL REGULATIONS**

EACH STATE HAS A BOARD OF NURSING THAT DEFINES AND REGULATES THE SCOPE OF PRACTICE WITHIN ITS JURISDICTION. FEDERAL LAWS MAY ALSO INFLUENCE SPECIFIC PRACTICE LIMITATIONS, ESPECIALLY CONCERNING MEDICATION ADMINISTRATION AND PATIENT PRIVACY.

### **EDUCATIONAL PREPARATION AND CERTIFICATION**

THE LEVEL OF NURSING EDUCATION AND SPECIALTY CERTIFICATIONS DIRECTLY IMPACT THE SCOPE OF PRACTICE. HIGHER EDUCATION AND CREDENTIALS ALLOW NURSES TO PERFORM MORE ADVANCED FUNCTIONS AND ASSUME GREATER RESPONSIBILITIES.

### **HEALTHCARE SETTING AND INSTITUTIONAL POLICIES**

THE WORK ENVIRONMENT, WHETHER ACUTE CARE, LONG-TERM CARE, OR COMMUNITY HEALTH, CAN MODIFY THE SCOPE BASED ON PATIENT POPULATION AND AVAILABLE RESOURCES. INSTITUTIONAL POLICIES MAY FURTHER RESTRICT OR EXPAND NURSING ROLES FOR SAFETY AND QUALITY ASSURANCE.

## **LEGAL AND ETHICAL CONSIDERATIONS IN NURSING SCOPE**

NURSES MUST ADHERE TO LEGAL STATUTES AND ETHICAL STANDARDS WHEN PRACTICING WITHIN THEIR SCOPE. VIOLATIONS CAN RESULT IN DISCIPLINARY ACTION, LOSS OF LICENSURE, OR LEGAL LIABILITY.

### **ACCOUNTABILITY AND PROFESSIONAL RESPONSIBILITY**

NURSES ARE ACCOUNTABLE FOR THEIR ACTIONS AND MUST ENSURE COMPETENCE IN ALL PERFORMED TASKS. PRACTICING BEYOND THE AUTHORIZED SCOPE CAN JEOPARDIZE PATIENT SAFETY AND VIOLATE PROFESSIONAL CODES OF CONDUCT.

### **DOCUMENTATION AND COMMUNICATION**

ACCURATE DOCUMENTATION OF NURSING CARE AND CLEAR COMMUNICATION WITH THE HEALTHCARE TEAM ARE ESSENTIAL TO DEMONSTRATE COMPLIANCE WITH SCOPE OF PRACTICE. THIS PROMOTES TRANSPARENCY AND CONTINUITY OF CARE.

## EXAMPLES OF ETHICAL PRACTICE RELATED TO SCOPE

- REFUSING TO PERFORM TASKS FOR WHICH THE NURSE IS UNTRAINED OR UNAUTHORIZED.
- MAINTAINING PATIENT CONFIDENTIALITY AND INFORMED CONSENT.
- REPORTING UNSAFE PRACTICES OR CONDITIONS THAT THREATEN PATIENT CARE.

## FREQUENTLY ASKED QUESTIONS
