

# NZ VISA UNDER ASSESSMENT

## UNDERSTANDING THE NZ VISA UNDER ASSESSMENT PROCESS

**NZ VISA UNDER ASSESSMENT** REFERS TO THE STAGE IN THE NEW ZEALAND VISA APPLICATION PROCESS WHERE YOUR APPLICATION IS CURRENTLY BEING REVIEWED BY IMMIGRATION OFFICIALS. THIS CRITICAL PHASE CAN LEAD TO VARIOUS OUTCOMES, INCLUDING APPROVAL, REQUEST FOR ADDITIONAL INFORMATION, OR REJECTION. ## WHAT DOES "UNDER ASSESSMENT" MEAN?

WHEN YOUR NZ VISA APPLICATION IS MARKED AS "UNDER ASSESSMENT," IT INDICATES THAT IMMIGRATION NEW ZEALAND (INZ) IS ACTIVELY EVALUATING YOUR APPLICATION. THIS PROCESS MAY INVOLVE SEVERAL STEPS AND CAN VARY IN DURATION DEPENDING ON MULTIPLE FACTORS, INCLUDING THE TYPE OF VISA YOU HAVE APPLIED FOR AND THE SPECIFIC CIRCUMSTANCES OF YOUR CASE.

## KEY PHASES OF THE ASSESSMENT PROCESS

1. **INITIAL REVIEW:** OFFICIALS WILL FIRST CHECK THAT ALL REQUIRED DOCUMENTS HAVE BEEN SUBMITTED AND THAT THE APPLICATION IS COMPLETE. INCOMPLETE APPLICATIONS MAY BE RETURNED FOR FURTHER INFORMATION.

3. **BACKGROUND CHECKS:** THE ASSESSMENT PROCESS MAY ALSO INCLUDE CHECKS AGAINST VARIOUS DATABASES TO ENSURE THERE ARE NO SECURITY OR HEALTH CONCERNS ASSOCIATED WITH YOUR APPLICATION.
4. **DECISION MAKING:** AFTER THOROUGH EVALUATION, A DECISION WILL BE MADE REGARDING YOUR VISA APPLICATION. THIS CAN TAKE SEVERAL WEEKS OR EVEN MONTHS, DEPENDING ON THE COMPLEXITY OF THE CASE.

## FACTORS INFLUENCING THE DURATION OF ASSESSMENT

THE TIME YOUR APPLICATION SPENDS "UNDER ASSESSMENT" CAN VARY WIDELY BASED ON SEVERAL FACTORS:

- **TYPE OF VISA:** DIFFERENT VISA CATEGORIES HAVE DIFFERENT PROCESSING TIMES. FOR INSTANCE, SKILLED WORKER VISAS MAY REQUIRE MORE DETAILED ASSESSMENTS THAN VISITOR VISAS.
- **COMPLETENESS OF APPLICATION:** A WELL-PREPARED APPLICATION WITH ALL NECESSARY DOCUMENTATION CAN EXPEDITE THE PROCESS.
- **VOLUME OF APPLICATIONS:** DURING PEAK TIMES, SUCH AS AFTER POLICY CHANGES OR DURING SPECIFIC SEASONS, PROCESSING TIMES MAY BE LONGER DUE TO INCREASED WORKLOADS.
- **ADDITIONAL INFORMATION REQUESTS:** IF INZ REQUIRES MORE INFORMATION OR DOCUMENTATION FROM YOU, THIS CAN EXTEND THE ASSESSMENT PERIOD.

# WHAT TO DO WHILE YOUR APPLICATION IS UNDER ASSESSMENT

WHILE YOUR VISA APPLICATION IS UNDER ASSESSMENT, THERE ARE SEVERAL STEPS YOU CAN TAKE:

## 1. STAY INFORMED

KEEP YOURSELF UPDATED ON THE STATUS OF YOUR APPLICATION BY REGULARLY CHECKING YOUR ONLINE ACCOUNT ON THE INZ WEBSITE. YOU MAY ALSO RECEIVE EMAILS OR NOTIFICATIONS REGARDING ANY UPDATES OR REQUESTS FOR ADDITIONAL INFORMATION.

## 2. PREPARE FOR POSSIBLE OUTCOMES

UNDERSTAND THE POTENTIAL OUTCOMES OF YOUR APPLICATION. BE PREPARED FOR:

- APPROVAL: IF YOUR APPLICATION IS APPROVED, YOU WILL RECEIVE A VISA GRANT LETTER WITH FURTHER INSTRUCTIONS.
- REQUEST FOR FURTHER INFORMATION: INZ MIGHT ASK FOR ADDITIONAL DOCUMENTS OR CLARIFICATION. RESPOND PROMPTLY AND THOROUGHLY TO AVOID DELAYS.
- REJECTION: IN CASE OF A REJECTION, YOU WILL RECEIVE A LETTER EXPLAINING THE REASONS. YOU MAY HAVE THE OPTION TO APPEAL OR REAPPLY, DEPENDING ON THE SITUATION.

## 3. DO NOT MAKE IRREVERSIBLE PLANS

SINCE VISA PROCESSING TIMES CAN BE UNPREDICTABLE, IT IS WISE TO AVOID MAKING IRREVERSIBLE TRAVEL OR RELOCATION PLANS UNTIL YOUR VISA IS GRANTED. THIS INCLUDES BOOKING FLIGHTS, SELLING PROPERTY, OR QUITTING YOUR JOB IN YOUR HOME COUNTRY.

# COMMON CHALLENGES DURING THE ASSESSMENT PROCESS

THE ASSESSMENT PROCESS CAN BE FRAUGHT WITH CHALLENGES THAT MAY LEAD TO DELAYS OR COMPLICATIONS. UNDERSTANDING THESE CHALLENGES CAN HELP YOU PREPARE BETTER.

## 1. INCOMPLETE DOCUMENTATION

ONE OF THE MOST COMMON REASONS FOR DELAYS IS INCOMPLETE OR INCORRECT DOCUMENTATION. ENSURE THAT YOU PROVIDE ALL REQUIRED DOCUMENTS AND THAT THEY MEET INZ'S GUIDELINES.

## 2. MISUNDERSTANDING VISA REQUIREMENTS

VISA REQUIREMENTS CAN BE COMPLEX AND VARY SIGNIFICANTLY BETWEEN DIFFERENT VISA CATEGORIES. MAKE SURE YOU FULLY UNDERSTAND THE SPECIFIC REQUIREMENTS FOR YOUR VISA TYPE.

## 3. CHANGES IN IMMIGRATION POLICY

NEW ZEALAND'S IMMIGRATION POLICIES CAN CHANGE, AFFECTING PROCESSING TIMES AND REQUIREMENTS. STAYING INFORMED ABOUT THESE CHANGES IS CRUCIAL.

## 4. SECURITY AND HEALTH CHECKS

LENGTHY SECURITY OR HEALTH CHECKS CAN ALSO EXTEND THE ASSESSMENT PERIOD. BE PREPARED FOR POSSIBLE REQUESTS FOR MEDICAL EXAMINATIONS OR POLICE CERTIFICATES.

## WHAT HAPPENS AFTER THE ASSESSMENT?

ONCE YOUR NZ VISA APPLICATION IS ASSESSED, YOU WILL RECEIVE A DECISION COMMUNICATED THROUGH YOUR ONLINE ACCOUNT OR VIA EMAIL. HERE'S WHAT TO EXPECT:

### 1. VISA GRANT NOTIFICATION

IF YOUR APPLICATION IS SUCCESSFUL, YOU WILL RECEIVE AN OFFICIAL VISA GRANT LETTER. THIS LETTER WILL CONTAIN VITAL INFORMATION, INCLUDING YOUR VISA CONDITIONS AND VALIDITY DATES.

### 2. ADDITIONAL INFORMATION REQUESTS

SHOULD INZ REQUIRE MORE INFORMATION, THEY WILL SEND YOU A REQUEST DETAILING WHAT THEY NEED. RESPONDING PROMPTLY CAN EXPEDITE THE PROCESS.

### 3. REJECTION NOTIFICATION

IF YOUR APPLICATION IS DENIED, YOU WILL RECEIVE A WRITTEN EXPLANATION. YOU MAY HAVE THE OPTION TO APPEAL THE DECISION OR RECTIFY ISSUES AND REAPPLY.

## CONCLUSION

NAVIGATING THE **NZ VISA UNDER ASSESSMENT** PROCESS CAN BE A DAUNTING EXPERIENCE, BUT UNDERSTANDING THE STAGES, WHAT TO EXPECT, AND HOW TO RESPOND CAN HELP EASE THE JOURNEY. IT IS ESSENTIAL TO BE PATIENT AND PROACTIVE DURING THIS TIME. ALWAYS REMEMBER TO KEEP COMMUNICATION LINES OPEN WITH INZ AND SEEK PROFESSIONAL ADVICE IF NEEDED TO ENHANCE YOUR UNDERSTANDING OF THE VISA APPLICATION PROCESS.

## FREQUENTLY ASKED QUESTIONS

### WHAT DOES IT MEAN WHEN MY NZ VISA IS UNDER ASSESSMENT?

WHEN YOUR NZ VISA IS UNDER ASSESSMENT, IT MEANS THAT IMMIGRATION NEW ZEALAND IS REVIEWING YOUR APPLICATION TO DETERMINE IF YOU MEET ALL ELIGIBILITY CRITERIA FOR THE VISA YOU'RE APPLYING FOR. THIS PROCESS CAN TAKE SOME TIME, DEPENDING ON VARIOUS FACTORS.

### HOW LONG DOES IT TYPICALLY TAKE FOR A NEW ZEALAND VISA TO BE ASSESSED?

THE PROCESSING TIME FOR A NEW ZEALAND VISA CAN VARY WIDELY BASED ON THE TYPE OF VISA, THE COMPLEXITY OF YOUR APPLICATION, AND CURRENT WORKLOAD AT IMMIGRATION NEW ZEALAND. GENERALLY, IT MAY TAKE ANYWHERE FROM A FEW WEEKS TO SEVERAL MONTHS.

## **CAN I CHECK THE STATUS OF MY NZ VISA APPLICATION WHILE IT'S UNDER ASSESSMENT?**

YES, YOU CAN CHECK THE STATUS OF YOUR NZ VISA APPLICATION THROUGH THE IMMIGRATION NEW ZEALAND ONLINE PORTAL, OR YOU CAN CONTACT THEIR CUSTOMER SERVICE FOR UPDATES. HOWEVER, DETAILED INFORMATION MAY NOT BE AVAILABLE DURING THE ASSESSMENT PROCESS.

## **WHAT SHOULD I DO IF MY NZ VISA APPLICATION IS TAKING LONGER THAN EXPECTED?**

IF YOUR NZ VISA APPLICATION IS TAKING LONGER THAN EXPECTED, YOU CAN REACH OUT TO IMMIGRATION NEW ZEALAND FOR AN UPDATE. ENSURE THAT ALL REQUIRED DOCUMENTS WERE SUBMITTED CORRECTLY AND THAT THERE ARE NO OUTSTANDING ISSUES THAT COULD DELAY YOUR APPLICATION.

## **WILL I BE NOTIFIED IF ADDITIONAL INFORMATION IS NEEDED FOR MY NZ VISA APPLICATION UNDER ASSESSMENT?**

YES, IF IMMIGRATION NEW ZEALAND REQUIRES ADDITIONAL INFORMATION OR DOCUMENTATION WHILE YOUR VISA APPLICATION IS UNDER ASSESSMENT, THEY WILL NOTIFY YOU VIA THE CONTACT INFORMATION YOU PROVIDED IN YOUR APPLICATION.
