

OHIO YOUTH ASSESSMENT SYSTEM

OHIO YOUTH ASSESSMENT SYSTEM IS A COMPREHENSIVE FRAMEWORK DESIGNED TO EVALUATE THE NEEDS AND RISKS OF YOUTH INVOLVED IN THE JUVENILE JUSTICE SYSTEM. UNDERSTANDING THE OHIO YOUTH ASSESSMENT SYSTEM

THE OHIO YOUTH ASSESSMENT SYSTEM SERVES AS AN INTEGRAL PART OF THE JUVENILE JUSTICE SYSTEM IN OHIO. IT ALLOWS PROFESSIONALS TO SYSTEMATICALLY ASSESS YOUTHS' RISK LEVELS AND SERVICE NEEDS, FOSTERING A MORE TAILORED APPROACH TO INTERVENTION AND SUPPORT. THE OYAS IS BUILT ON THE PRINCIPLES OF RISK, NEED, AND RESPONSIVITY, GUIDING PRACTITIONERS IN THEIR EFFORTS TO IMPROVE OUTCOMES FOR YOUTH.

THE PURPOSE OF OYAS

COMPONENTS OF THE OYAS
