- HOW TO HANDLE VEHICLE BREAKDOWNS: SAFETY TIPS SUCH AS STAYING IN THE VEHICLE, USING HAZARD LIGHTS, AND CALLING FOR HEI P.

5. STATE-SPECIFIC RULES AND REGULATIONS

EACH STATE MAY HAVE UNIQUE LAWS THAT DRIVERS MUST KNOW. INCLUDE:

- ALCOHOL LIMITS: UNDERSTAND THE LEGAL BLOOD ALCOHOL CONCENTRATION (BAC) LIMIT.
- LICENSING REQUIREMENTS: SPECIFIC AGE REQUIREMENTS, SUCH AS MINIMUM AGE FOR OBTAINING A LEARNER'S PERMIT OR FULL LICENSE.
