PHILOSOPHERS, EDUCATORS, AND CITIZENS ENGAGE IN CONVERSATIONS THAT RESHAPE SOCIETAL NARRATIVES, NORMS, AND INSTITUTIONS TO REFLECT EVOLVING IDEALS OF JUSTICE AND SOLIDARITY.

DEMOCRACY AND SOLIDARITY AS FOUNDATIONS OF SOCIAL HOPE
