OVERVIEW OF PHYSICAL THERAPY CPT CODES

PHYSICAL THERAPY CPT CODES ARE PART OF THE BROADER CPT CODING SYSTEM DEVELOPED BY THE AMERICAN MEDICAL ASSOCIATION (AMA) TO STANDARDIZE REPORTING OF MEDICAL, SURGICAL, AND DIAGNOSTIC SERVICES. THESE CODES ENABLE PHYSICAL THERAPISTS TO COMMUNICATE THE SPECIFIC SERVICES THEY PROVIDE TO PATIENTS AND INSURERS ACCURATELY. THE CPT CODES FOR PHYSICAL THERAPY MOSTLY FALL WITHIN THE 97000 SERIES, WHICH COVERS THERAPEUTIC PROCEDURES AND EVALUATIONS.

- **97110** – THERAPEUTIC EXERCISES: UTILIZED FOR EXERCISES AIMED AT IMPROVING STRENGTH, ENDURANCE, FLEXIBILITY, AND RANGE OF MOTION.
- **97112** – NEUROMUSCULAR RE-EDUCATION: COVERS TECHNIQUES THAT IMPROVE MOVEMENT, BALANCE, COORDINATION, AND PROPRIOCEPTION.
- **97116** – GAIT TRAINING THERAPY: USED FOR INTERVENTIONS THAT FOCUS ON IMPROVING WALKING ABILITY AND MOBILITY.
- **97140** – MANUAL THERAPY TECHNIQUES: INCLUDES HANDS-ON TREATMENTS SUCH AS MOBILIZATION, MANIPULATION, AND MASSAGE.
- **97530** – THERAPEUTIC ACTIVITIES: ENGAGES PATIENTS IN FUNCTIONAL ACTIVITIES TO ENHANCE DAILY LIVING SKILLS AND OVERALL FUNCTION.

ADDITIONAL RELEVANT CPT CODES

OTHER CPT CODES FREQUENTLY UTILIZED IN PHYSICAL THERAPY INCLUDE THOSE FOR MODALITIES SUCH AS ULTRASOUND, ELECTRICAL STIMULATION, AND HYDROTHERAPY. THESE INCLUDE:

- **97010** – APPLICATION OF A MODALITY TO ONE OR MORE AREAS; HOT OR COLD PACKS
- **97014** – ELECTRICAL STIMULATION (UNATTENDED)
- **97124** – MASSAGE THERAPY
- **97535** – SELF-CARE/HOME MANAGEMENT TRAINING

GUIDELINES FOR USING PHYSICAL THERAPY CPT CODES

ADHERENCE TO CODING GUIDELINES IS ESSENTIAL TO ENSURE CORRECT USAGE OF PHYSICAL THERAPY CPT CODES. THESE GUIDELINES OUTLINE WHEN AND HOW TO APPLY EACH CODE BASED ON THE SERVICE PROVIDED, DOCUMENTATION REQUIREMENTS, AND PAYER-SPECIFIC RULES.

DOCUMENTATION REQUIREMENTS

THOROUGH DOCUMENTATION MUST ACCOMPANY EACH CPT CODE BILLED. THIS INCLUDES DETAILED NOTES ON THE PATIENT'S CONDITION, THE TREATMENT PROVIDED, DURATION, AND RESPONSE TO THERAPY. DOCUMENTATION SUPPORTS MEDICAL NECESSITY, JUSTIFIES THE USE OF SPECIFIC CODES, AND FACILITATES AUDITS OR REVIEWS.

TIME-BASED CODING CONSIDERATIONS

- **MODIFIER KX:** REQUIREMENTS MET FOR EXTENDED THERAPY SERVICES
